# 1. Executive Summary

- 1.1 The Boundary Commission is an independent and impartial advisory public body, which reviews the boundaries of Parliamentary constituencies in England.
- 1.2 On 13 September 2016, the Boundary Commission published the first set of proposals which was a full map of the new parliamentary constituencies for its first consultation which ends on the 5 December 2016.
- 1.3 It was agreed in-principle by all the Political Group Leaders to a Cross Party representation to the Boundary Commission draft proposals. Both the Conservative and Labour Groups have agreed to the wording of the draft letter. The Liberal Democrat Group have yet to agree the wording, although it is anticipated that any proposed amendment may be considered with this report.

# 2. Recommendation

2.1 Agree that the draft letter as set out as Appendix A be sent as a Council response to the first Boundary Commission consultation.

# 3. Introduction and Background

3.1 The Government Parliament has asked the Boundary Commission, as an independent and impartial public organisation, to conduct a review of all the constituency boundaries in England.

# 4. Issue, Options and Analysis of Options

- **4.1** The task is twofold: to reduce the number of constituencies (from 650 to 600); and to make more equal the number of electors in each constituency, no fewer than 71,031 and no more than 78,507.
- 4.2 The proposals include various changes to the existing seat of Brentwood& Ongar which currently includes the entire Borough of Brentwood.
- 4.3 The proposals would remove the electoral wards of Warley and Herongate, Ingrave and West Horndon out of the Brentwood & Ongar constituency into an enlarged South Basildon & East Thurrock seat, dividing the Borough of Brentwood into two Parliamentary Constituencies.
- 4.4 In addition to this consultation there will be two further consultations held in 2017.
- 4.5 The Boundary Commission are required to submit their final report and recommendations to Parliament in September 2018.

# **Boundary Commission Consultation**

At its meeting on the 19<sup>th</sup> October 2016 the Council formally agreed to provide this letter as a representation to the current consultation on the draft proposals for the Brentwood area.

The Council notes the draft plans, which include various changes to the existing parliamentary seat of the Brentwood & Ongar constituency.

The proposals would move the electoral wards of Warley and Herongate, Ingrave and West Horndon from the Brentwood & Ongar Constituency into an enlarged South Basildon & East Thurrock seat, dividing the Borough of Brentwood into two Parliamentary Constituencies. This would also see the key local landmark of Brentwood Station be split between the two constituencies of Brentwood and Ongar and SBET.

Whilst the Council understands there are proposals for boundary changes to reduce the number of constituencies in the UK from 650 to 600, we are concerned that the current proposals potentially threaten the borough's boundaries, causing issues of identity that have been raised by the residents of Warley, Herongate, Ingrave and West Horndon. Although this boundary review focuses on the parliamentary seat, we wish to take the opportunity to formally place on record the importance of keeping the borough boundaries as they are; under the remit of Brentwood Borough Council.

The Council therefore calls upon the Boundary Commission to confirm that any changes will consider issues of identity and will not affect the borough boundaries of Brentwood Council
