# 1. Executive Summary

- 1.1 This report provides information of an application for a variation to the premises licence in respect of *Cafe Lowe, 2-2A Victoria Road, Warley, Brentwood CM14 4AP*
- 1.2 Members are requested to determine the application having regard to the operating schedule, the representations received, the Council's Statement of Licensing Policy and the four Licensing objectives.

# 2. Recommendation

- 2.1 Each application must be considered on its individual merits and, therefore, no recommendations may be made. However, the available options are:
  - i) To grant the application in full on the terms and conditions contained in the operating schedule along with any applicable mandatory conditions;
  - ii) To grant the application, modified to such extent as considered appropriate in order to satisfy any relevant representations and to promote the licensing objectives; or
  - iii) To reject the application

# 3. Introduction and Background

3.1 An authorisation is required in respect of any premises where it is intended to conduct one or more of the four licensable activities, these being:

- Sale of alcohol
- Supply of alcohol (in respect of a club)
- Regulated Entertainment
- Provision of Late Night Refreshment
- 3.2 An appropriate authorisation is either, a premises licence, a club premises certificate or a Temporary Event Notice.
- 3.3 Licence holders are required, when offering any licensable activity, to ensure that they promote the licensing objectives at all times. The operating schedule of the application contains details of the activities applied for and the control measures that the applicant will have in place in order to promote these objectives. Such measures will, where appropriate, be converted into enforceable conditions on any licence issued. Those pertaining to this particular application are reproduced in paragraphs 4 and 5 of this report.
- 3.4 The four licensing objectives are;
  - Prevention of crime and disorder
  - Prevention of public nuisance
  - Public safety
  - Protection of children from harm

No objective carries any more weight than any other.

3.5 Any representation must be able to demonstrate that on the balance of Probability the application in its current form will fail to adequately promote one or more of the licensing objectives. No other matters may be considered.

# 4. The Application

- 4.1 This application was received on 13 January 2016 from Mr Robert Lowe in respect of Cafe Lowe, 2-2A Victoria Road, Brentwood CM14 5EE.
   A copy of the application is attached at *Appendix 1*.
- 4.2 The applicant describes the premises as a small cafe which serves 26 covers with breakfasts and evening meals set in a semi-residential and commercial area. A map of the location is also attached at *Appendix 4.*
- 4.3 The applicant seeks a premises licence for the provision of the sale of alcohol for the following hours; **10:30hrs-00:00hrs daily** and late night refreshment for the following hours; **23:00hrs-00:00hrs daily**

- 4.4 The following conditions have been proposed by the applicant in the operating schedule;
  - Any music will generally be by way of incidental background music
  - The premises shall adopt a Challenge 25 Policy where it appears to a member of staff that a person is over 18 years the proof of age documents that will be accepted to establish that the person is over 18 years. Acceptable forms of photographic identification include;
    - a) Photo card Driving Licence
    - b) Passport
    - c) a 'PASS' accredited proof of age card
    - d) a Military ID
  - Staff training will be conducted by the DPS with regards to the responsible retailing of alcohol.
  - All food and trade waste will be removed according to the trade waste contract.

# 5. Reasons for Recommendation

If Members are minded to grant the application:

- 5.1 The applicant has, after consultation with the Police, also stated that:
  - Alcohol shall only be sold ancillary to a table meal as defined by s.159 Licensing Act 2003.
  - No drinks or glassware shall be permitted outside the premises.
- 5.2 Any application granted will automatically contain conditions from paragraph 4. The additional conditions contained in this paragraph may be added by members if granting and considered appropriate for the promotion of the licensing objectives.

All such proposals will be converted into conditions on a licence if granted.

# 6. Consultation

- 6. The regulations of the Licensing Act 2003 outline the requirements for the advertising of applications. These require the applicant to advertise the application:
  - (b) For a period of no less than 28 consecutive days starting on the day after the day on which the application is given to the relevant licensing authority or display a notice ... prominently at or on the premises to which the application relates where it can be conveniently read from the exterior of the premises...
  - (c) By publishing a notice in a local newspaper ... on at least one occasion during the period of ten working days starting on the day after the day on which the application was given to the relevant licensing authority.
- 6.2 Regulations also require that the applicant give a copy of the application to each responsible authority on the same day upon which it is given to the licensing authority.
- 6.3 There are no other statutory requirements for advertising of any application, however, the relevant Ward Councillors are notified and details of all applications received along with the time limit for receipt of representations is posted on the Council website.
- 6.4 Officers from the licensing authority have made checks on the display of notices on several occasions. On each visit a single blue advertising notice was correctly displayed in the front window.
- 6.5 There have been 2 valid representations received from the Responsible Authorities. Representations from Essex Police (Licensing) and the Environmental Health (Noise Pollution) are attached at *Appendix 2.*
- 6.6 There have been 10 valid representations received from interested parties. All are made by residents of Victoria Road living in close proximity to the premises. At present, the cafe premises is generally closed by 3pm and this raises potential public nuisance concerns emanating from the additional hours the applicant is intending to operate. Residents above the premises have noise concerns from the apparent poor sound insulation and nuisance issues associated with the operating of the kitchen. These representations, together with a response from the applicant's agent are attached at *Appendix 3.*
- 6.7 Three representations were deemed invalid as they were not compliant with the regulations in accordance with the consultation period.
- 6.8 An OS Street Map and frontage images to better identify the location are attached at *Appendix 4.*

# 7. Statement of Licensing Policy

- 7.1 There are no specific issues arising from this application in relation to the Councils' Statement of Licensing Policy.
- 7.2 The following extracts from the Councils' Statement of Licensing Policy are brought to the general attention of Members:

(1.4) Nothing in this Statement of Policy should be regarded or interpreted as an indication that any requirement of law may be overridden; each application will be considered and treated on its own merits.

(7.1) When considering applications, the Licensing Authority will have regard to:-

- (a) The Licensing Act 2003, as amended and the licensing objectives.
- (b) Government guidance issued under Section 182 of the Licensing Act 2003, as amended.
- (c) Any supporting regulations.
- (d) This Statement of Licensing Policy.

(9.1) Licensing is about the appropriate control of licensed premises, qualifying clubs, temporary events and the people who manage them or hold personal licences within the terms of the 2003 Act. Where relevant representations are made, the Licensing Authority will seek to make objective judgments as to whether conditions may need to be attached to various authorisations in order to secure achievement of the licensing objectives. Any conditions arising from the operating schedule or as a result of representations will primarily focus on the direct impact of the activities taking place at licensed premises on those attending the premises and members of the public living, working or otherwise engaged in normal activity in the area concerned. These conditions will cover matters that are within the control of individual licensees and others with relevant responsibilities.

(9.2) The Licensing Authority acknowledges that the licensing function cannot be used for the general control of nuisance or the antisocial behaviour of individuals once they are beyond the direct control of the licensee of any premises concerned. However, other mechanisms may be utilised, where appropriate, to tackle unruly or unlawful behaviour of consumers when beyond the control of the individual, club or business holding the licence, certificate or authorisation concerned. These include:

(a) Planning controls.

(b) Positive measures to create a safe and clean town environment in partnership with local businesses, transport operators and other services within the Local Authority.

(c) The provision of CCTV surveillance in town centres, ample taxi ranks, street cleaning and litter patrols.

(d) Powers of Local Authorities to restrict consumption of intoxicating liquor in designated public places other than Premises licensed for 'on' sales.

(e) Police enforcement of the general law concerning disorder and antisocial behaviour, including the issuing of fixed penalty notices.

(f) The prosecution of any personal licence holder or member of staff at such premises who is selling alcohol to people who are drunk.(g) The confiscation of alcohol from children and adults in designated areas.

(h) The power of the Police, other responsible authorities or a local resident or business to seek a review of the licence or certificate in question.

(i) Action under the Violent Crime Reduction Act 2006.

(11.1) There can be confusion about the difference between "need" and the "cumulative impact" of premises on the licensing objectives. "Need" concerns the commercial demand for another pub or restaurant or hotel. This is not a matter for a licensing authority in discharging its licensing functions or for its Statement of Licensing Policy.

(16.6) The Licensing Authority considers the effective and responsible management of the premises, instruction, training and supervision of staff and the adoption of best practice to be amongst the most essential control measures for the achievement of all the licensing objectives. For this reason, these elements should be specifically considered and addressed within an applicant's operating schedule.

# 8. Relevant Sections of the Secretary of State's Guidance

8.1 The following extract of the section 182 guidance as published by the Secretary of State are brought to the attention of Members.

(9.41) Licensing authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case-by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.

(9.42) The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.

(9.43) Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to achieve that end. Whilst this does not therefore require a licensing authority to decide that no lesser step will achieve the aim, the authority should aim to consider the potential burden

that the condition would impose on the premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives. However, it is imperative that the authority ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the objectives and nothing outside those parameters. As with the consideration of licence variations, the licensing authority should consider wider issues such as other conditions already in place to mitigate potential negative impact on the promotion of the licensing objectives and the track record of the business. Further advice on determining what is appropriate when imposing conditions on a licence or certificate is provided in Chapter 10. The licensing authority is expected to come to its determination based on an assessment of the evidence on both the risks and benefits either for or against making the determination.

# 9. Legal Considerations

- 9.1 Conditions may be attached to the grant of any licence, the hours or activities may be amended as appropriate, or in some cases the application may be refused. However, any action taken must be appropriate and relevant to promotion of the licensing objectives having considered the full details of the application and representations including testimony from any interested party present at the hearing.
- 9.2 The justification behind any decision to grant or refuse a licence application or the attachment of conditions, or variation of terms applied for must be recorded and given to the applicant and any person that has made representation.
- 9.3 There is a right of appeal to Magistrates Court by any person or party aggrieved by any decision made by the Sub-Committee.



## Licence Application for a Premises Licence under the Licencing Act 2003

I refer to the above application received on 14<sup>th</sup> January 2016 by the Pollution Team of the Council.

I wish to make representation to the Licensing Authority in respect of this application, as in my opinion the application contains insufficient information to demonstrate that the licensing objective of prevention of public nuisance will be achieved.

Cafe Lowe is situated in the centre of Warley in Victoria Road which is off Warley Hill. It has flats located directly above it and majority of the properties in Victoria Road are essentially residential. There are several licenced premises in Warley Hill which consist of mainly restaurants and takeaway premises. The Essex Arms which is located in Warley Hill is a Public House which provides music entertainment.

Warley Hill is generally a busy area in the evening as there are commuters coming into the Brentwood Station. By 10 pm most of the commuter traffic has reduced and some of the takeaway premises are closing so the area is relatively quiet.

The premises applied for a change of use to a cafe/takeaway in May 2011 and was recommended for a refusal on the grounds that the proposed change would cause noise and disturbance by customers entering and leaving the premises and noise associated with vehicle parking and manoevering.

However, permission was granted on appeal in June 2012. The hours imposed by the Planning Committee were as follows:



Monday to Friday	07:00 to 23:00
Saturdays	09:00 to 23:00
Sundays	09:00 to 14:00
And Public Holidays	18:00 to 22:00

As far as I am aware, the premises have not used these hours and are generally closed by 18:00. I expect it is for this reason that the Environmental Health Department have not received any complaints from the residents living nearby.

The application is seeking to extend the opening hours as follows:

Monday to Sunday 11:00 to 23:30

Additionally they want to extend the opening hours on the first Saturday of every month until 00:30.

On New Years Eve, they want to extend the opening hours until 01:30

At present the premises has 30 covers. There is no allocated area for smokers. Any customers wanting to smoke would need to go out onto the pavement directly outside the premises or onto Warley Hill.

The application also proposes background music.

I have concerns about this application with regard to the prevention of public nuisance objective.

In particular, I wish to make a representation on the following matters:

- There are insufficient controls stated in the application for the prevention of noise. Disturbance from speech from upto 30 customers and the staff until a later hour both from within the premises and from customers congregating outside to smoke is likely to cause disturbance to the nearby residents.
- 2. The background music is most likely to be heard in the flat above the premises and could therefore cause disturbance.
- 3. There will be additional litter consisting of cigarette butts etc, in the pavement outside the premises from customers.

It is therefore my opinion that in the absence of suitable measures within the operating schedule the Licensing Authority should consider the following matters of concern with regard to the objective of prevention of public nuisance:

- 1. The hours proposed are considered too late as they are likely to cause a noise disturbance to the nearby residents.
- 2. Amplified music being played until a later hour is likely to cause disturbance.
- 3. The potential from litter caused by the customers is likely to increase.
- 1. The opening hours should be limited to:

Monday to Friday

07:00 to 22:30

Saturdays and Sundays

09:00 to 22:30

- 2. No amplified music to be played within the premises, unless the applicant can suitably demonstrate that the sound insulation within the premises is sufficient so as not to cause disturbance to the occupiers of the flat above.
- 3. Ashtrays will be provided for the benefit of customers using the outside areas. These must be emptied throughout the evening if required and/or the start of the business the following day.
- 4. At the end of the trading hours, the outside of the premises is left clear of litter.

I am the owner and landlord of the flat directly above the CAFE LOWE on Victoria road, Brentwood, and have been successfully renting it out for two years.

It was brought to my attention by my current tenants that an application has been made to extend hours and serve alcohol until midnight.

Prior to this application my tenants have been forced to call the police several times because of night time disturbances caused by drunk behaviour which will no doubt be on record with the police. This will only increase if a late night alcohol licence is granted to the cafe below their flat.

The operating hours of the cafe are alreadyfrom 7.00 a.m. in the morning. To allow an additional alcohol licence until midnight will give my tenants and local residents virtually no respite from noise disruption from the cafe's late night drinking customers. It is not necessary or beneficial for the local residents to have yet another place serving alcohol until midnight when that part of Brentwood is sufficiently catered for.

In addition there is incredibly limited parking in the area and extending the facility will impact on residents being able to park. It will make parking in the evening even more difficult than it already is which is unfair on residents.

Allowing an alcohol licence until midnight will directly impact on the quality of life my tenants can enjoy and, as a consequence, they have already informed me if a licence is granted they will have to find alternative accommodation.

From my perspective, as the property owner and landlord, it will be incredibly difficult to find anyone prepared to have commercial noise and disruption to their home life from 7.00 a.m. until midnight if a licence is granted. In my experience bars that stop serving alcohol at a certain time take at least another hour to finally close which would mean the hours of business for the cafe extending to 1.00 a.m. In the morning. Six hours later it will all start again. That equates to 18 hours in anygiven day when my tenants will have to tolerate noise and disruption. Eight hours of sleep/ rest time is not a luxury but a necessity. Extending the licence would mean they would be lucky to get six hours of rest while the cafe is closed. I am sure the owner and applicant of the cafe would object if a similar invasion into his life from a business seeking to operate in such a close proxomity to his residents were looking to operate for a stretch of 18 hours in a day.

There are more than enough establishments already in and around that part of Brentwood that serve alcohol until late that are not in an area which is specifically geared toward residents. To grant an application for such a licence will not improve the area in anyway but will be hugely negative.

To summarise it will be to the detriment of the area to grant an extended late night alcohol licence in a residential area and, apart from financially benefitting the cafe owner, will significantly impact on the quality of life of local residents and reduce the value of their properties. There is nothing that can be gained by the local residents accommodating yet another late night drinking establishment in this residential area and, from my perspective, it will cause my tenants an unacceptable level of noise and disruption.

We are the current tenants residing at 2b Victoria Road, Brentwood, the property is located directly above Café Lowe of Brentwood. We have been tenants of the above mentioned property for 2 years and had the intention of staying for at least another year within the property.

We have noticed that the owner of Café Lowe has made an application for a licence to increase hours of operation & for the sale of alcohol. The document within the Café window states that the licence request is to serve alcohol between the hours of 10:00-00:00.

We already suffer from a number of disturbances from people under the influence of alcohol, as there are already a number of Bars/sports venues nearby. As a result have already had to contact the police to deal with the situation, as I am sure you are already aware of. We feel this will only increase if a late night alcohol licence is granted to the cafe below our flat.

### D.E GOOVITIABRE

The Café currently opens at 7:00am and operates until 15:00pm, with the new licence the Café will be operating from 7:00am until 00:00. These hours aren't including any hours which it will take the Café staff to close down of an evening, this would add at least another 30-60 minutes on to the time that the disruption will cease. Allowing a licence for these hours will provide us with no rest period; we both work demanding jobs and need as much rest-during our time away from the working environment as possible.

It is recommended that people should ensure at least 8 hours of sleep, to be able to operate at an optimum, the hours which the licence extension are now suggestion means that we would only have the opportunity to gain 6 hours of undisturbed sleep each evening. Further to this I unfortunately, also suffer from a medical illness called Fibromyalgia which causes its sufferers, to experience chronic tiredness and fatigue. Research has proven that there is a link between gaining more hours of undisturbed sleep and the reduction of symptoms felt by a person. I can only feel as though the disruption I will experience during the night and weekends could severely compromise my health.

Furthermore, my partner suffers from Asthma, currently if there is someone smoking downstairs outside of the Café, this filters through to our windows as all face out above the Café doors, this can have a severe impact on her Asthma symptoms, causing coughing fits and also recurrent chest infections. If the hours were to be extended, particularly with an alcohol license the hours in which smoking outside will increase as there is no other smoking area for the Café customers, this will have a detrimental impact to her health and wellbeing.

Another objection raised is that, the parking on Victoria Road is extremely difficult already, without the impact of this business increasing its hours. As a resident we pay yearly for our parking permit, and often find we have to park down the very end of Victoria Road, as all of the spaces have already been taken, or far too frequently there is nowhere to park at all. On a Saturday morning when the Café is open, the customers repeatedly park illegally and pull up at the dead end and leave their car's there, which are not in a bay and makes it very difficult for you to turn around and drive out of Victoria road(please see picture attached). This parking is already dangerous and will only increase with the extended opening hours and availability of alcohol. Our car has already had numerous scratches and bumps being parked along this road, I can only think this will increase drastically with the increase in cars. As residents we have to pay to park our car, which is often near impossible yet more cars and people will be fighting over the limited spaces there are due to the potential of this new license.

I am writing this letter in objection to Cafe Lowe obtaining an alcohol license with extended opening hours.

We already suffer with youth crime (cars scratched/bottles being smashed/general vandalism) and drug dealing in the dead end road where Cafe Lowe is situated in Victoria Road that my children and I have to witness. The dead end road seems to attract lots of unsavoury people. The police have been called on occasions to deal with problems.

There are sometimes groups of kids hanging about on the paved area outside the cafe in the evenings when the cafe is closed so if they start to sell alcohol I fear older kids will buy it for them. They kids are boisterous enough without fuelling them with alcohol. You cannot talk to them as they are rude, obnoxious and intimidating.

We have the Essex Arms public house just across the road that brings its own problems from pub goers leaving late and shouting and fighting with smashed bottles and glass all over our street and then urinating behind the chip shop. Sometimes we have seen this is broad daylight, my daughter comes in from playing outside to tell me there is someone doing a wee down the alleyway, which is absolutely disgusting. At times I do wonder if I am living in Brentwood. I think the area around Victoria Road needs a bit of attention/regeneration/better policing, as in the last 6-12 months myself and a few other neighbours agree that the whole area has gone downhill. For the owner of Café Lowe, no doubt he will be at home whilst he employs someone else to run this venture into the early hours of every evening whilst we as residents will have to deal with the noise, the crime, the rubbish, the parking issues and the anti-social behaviour.

I also understand that there was a Turkish restaurant before Cafe Lowe and my neighbour tells me they tried to obtain an alcohol license but this was denied so I see no reason why Cafe Lowe should be treated any different. I have never visited a café that sells alcohol in all my life.

I think as residents we are entitled to our peace and quiet as we already put up with quite a lot as it is. I am in bed mostly by 10pm as I am up at 6am every morning for work, to be kept awake until midnight each night with the comings and goings at the café will be unbearable. I honestly don't see a point in the selling of alcohol when we already have 2 off-licenses and a pub within 5-10 seconds of the café.

This letter I believe has highlights a few of the points in regards to 'licensing objectives'. I look forward to hearing from you soon with news about this application.

#### **Members Interests**

Members of the Council must declare any pecuniary or non-pecuniary interests and the nature of the interest at the beginning of an agenda item and that, on declaring a pecuniary interest, they are required to leave the Chamber.

#### • What are pecuniary interests?

A person's pecuniary interests are their business interests (for example their employment trade, profession, contracts, or any company with which they are associated) and wider financial interests they might have (for example trust funds, investments, and asset including land and property).

#### • Do I have any disclosable pecuniary interests?

You have a disclosable pecuniary interest if you, your spouse or civil partner, or a person you are living with as a spouse or civil partner have a disclosable pecuniary interest set out in the Council's Members' Code of Conduct.

#### • What does having a disclosable pecuniary interest stop me doing?

If you are present at a meeting of your council or authority, of its executive or any committee of the executive, or any committee, sub-committee, joint committee, or joint sub-committee of your authority, and you have a disclosable pecuniary interest relating to any business that is or will be considered at the meeting, you must not :

- participate in any discussion of the business at the meeting, of if you become aware of your disclosable pecuniary interest during the meeting participate further in any discussion of the business or,
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

#### • Other Pecuniary Interests

Other Pecuniary Interests are also set out in the Members' Code of Conduct and apply only to you as a Member.

If you have an Other Pecuniary Interest in an item of business on the agenda then you must disclose that interest and withdraw from the room while that business is being considered

#### • Non-Pecuniary Interests

Non –pecuniary interests are set out in the Council's Code of Conduct and apply to you as a Member and also to relevant persons where the decision might reasonably be regarded as affecting their wellbeing.

A 'relevant person' is your spouse or civil partner, or a person you are living with as a spouse or civil partner

If you have a non-pecuniary interest in any business of the Authority and you are present at a meeting of the Authority at which the business is considered, you must disclose to that meeting the existence and nature of that interest whether or not such interest is registered on your Register of Interests or for which you have made a pending notification.

#### Licensing Sub-Committees

To hear and determine applications that do not sit within the scope of delegation to officers, usually where representations have been received either by a third party against grant of a license, or from the applicant against intended refusal or revocation of a license/registration.

The Planning and Licensing Committee has delegated all functions other than relevant policies and fees setting to officers, with the exception of those other matters as indicated below, which are heard by licensing sub-committee unless otherwise indicated:

#### Licensing Act 2003 and Gambling Act 2005

(a) Determination of any application type where a representation has been received in accordance with the legislation.

(b) Determination of applications for review or expedited review.
