Summary

The Council introduces a term time car parking season ticket for King George's Playing Field, made available to students and school employees should they wish to purchase one.

Recommendation(s)

Members are asked to:

R1. Agree the introduction of a term time season ticket for King George's Playing Field from 1st April 2023 at a cost of £950 per annum.

Main Report

Introduction and Background

- Fees and charges made by the Council for numerous services are reviewed on an annual basis by the relevant Committees relating to the services provided. Recommended amendments to the fees and charges are incorporated into the budget setting process to take effect from the following budget year.
- 2. The Parking fees and charges were considered on 23rd November 2022 by this committee and adopted following the approval of the budget at Full Council on 1st March 2023.

- Since the adoption of the budget the parking department have suggested a solution regarding the enquiries, they receive from local secondary schools regarding parking for their sixth form students.
- 4. Therefore, as this is a new additional charge proposed to what has already been approved, this committee is asked to consider the proposal and approve the new charge to be implemented from 1st April 2023.

Issue, Options and Analysis of Options

- 5. The Council is proposing to offer students and employees of local schools and nurseries the option of purchasing a term time season ticket for King George's playing field car park.
- 6. There is an average 190 days per school year, and it is proposed to offer a season ticket of £950. This equates to £5 per day parking. The day charge for the MSCP at Coptfold Road will be £6 from 1st April and £6.60 for all other car parks. Therefore, this option would save a customer £190-£304 depending on the car park and if they are parking every day.
- 7. King George's Playing Field Car Park during term time is underutilised and is near three secondary schools, Brentwood County High School, Brentwood Ursuline Convent School, and Brentwood School.
- 8. Some students are currently parking in the Town Hall North Car Park or MSCP. However, the current season tickets being purchased for the MSCP are administration heavy as this involves entering and removing student's car registration from the ANPR as they are purchasing tickets monthly.
- 9. If these decided to park at King George's this will reduce the administrative burden and free up limited parking at the town hall during the day.
- 10. It is proposed the season ticket could be payable monthly.
- 11. Following approval, the parking department will contact local schools and nurseries to offer the opportunity of purchasing the season ticket.

Reasons for Recommendation

12. To support residents and employees who work in the schools an incentive to park at a reduced cost to the current day rates, utilising spaces in an under

used car park so town centre car parks can support local businesses and shoppers within the town centre.
