#### **Licensing Act 2004**

Application for grant of a Premises Licence under the Licencing Act 2003

Brave Nelson, 138 Woodman Road, Brentwood, Essex.

I refer to the above application which was received on Wednesday 10<sup>th</sup> September 2014.

I wish to make a representation to the Licensing Authority in respect of this application, as in my opinion the application contains insufficient information to demonstrate that the licensing objective of prevention of public nuisance will be achieved.

The Brave Nelson is situated in Woodman Road surrounded by residential properties.

The hours of opening proposed are as follows:

Sunday to Thursday

10:00 to 23:30

Friday and Saturday

10:00 to 00:00

With additional hours on Christmas Eve, Boxing Day and New Years Eve.

The applicant proposes to have live music and recorded music until 23:00 every night and this is permissible under the Live Music Act 2012.

The applicant has proposed that the public use of the garden will cease at 22:00



The Environmental Health Department have had a number of complaints regarding noise disturbance caused by the music being played at the premises, from the customers in the garden area and from the children's playing area and the Bouncing Castle which they have on an occasional basis.

It is therefore my opinion that in the absence of suitable measures within the operating schedule of the Licencing Authority should consider the following matters of concern with regard to the objective of prevention of public nuisance:

- 1. The level of the music at the premises is not sufficiently controlled;
- 2. The use of the children's play area being open until 22:00 is considered to late.

I would therefore recommend that the following conditions be imposed:

- A suitable noise limiter of a type and specification to the approval of the Licensing Authority shall be installed and operate throughout the performance of live or recorded music at the premises. The electricity supply to all amplification equipment shall at all times be controlled by the noise limiter, which shall be set at a level to be agreed with the Pollution Team.
- 2. Self closers to be fitted on all the doors that open to the front of the premises and into the garden and the doors shall not be fixed open whilst music is being played to avoid noise breakout from the premises.
- 3. The children's play area and the bouncing castle when provided, will not be used after 19:00.
