

Register of Members' Interests - General Notice of Registerable Interests

class, the total nominal value of the shares of any one
class in which you or any person referred to above has a
beneficial interest that exceeds one hundredth of the
total issue share capital of that class

Other Pecuniary Interests

I also acknowledge that it may be a breach of the Code of Conduct to:

- 1. omit information that ought to be given in this notice;**
- 2. provide information that is materially false or misleading;**
- 3. fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change in circumstances**
