

Register of Members' Interests - General Notice of Registerable Interests

A member of Brentwood Borough Council, set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and have put 'None' where I have no such interest under any heading.

Disclosable Pecuniary Interests

4. Any land in your authority's area in which you have a beneficial interest* Petitts Farm
5. Any land in the authority's area for which you or the persons referred to above have a licence (alone or jointly with others) to occupy for a month or longer* Brick House Farm, Palmers Farm
6. Any tenancy where, to your knowledge, the landlord is your authority and the tenant is a body in which you or a person referred to above has a beneficial interest* No
7. The name of any person or body in which you or a person referred to above has a benefit interest in securities of that body where: *
(a) that body, to your knowledge, has a place of business or land in the area or your authority; and
(b) either –
(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issue share capital of that body; or
(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or any person referred to above has a beneficial interest that exceeds one hundredth of the total issue share capital of that class

Other Pecuniary Interests

Members are only obliged to register their own interests under this heading and do not need to include the interests of husbands/wives/civil partners or others

1. The name of the person who employs or has appointed Pettits Farm (AJ McCheyne & Son) you, the name of any firm in which you are a partner, and the name of any company for which you are a remunerated director*

Registerable Non-Pecuniary Interests

- 2. provide information that is materially false or misleading;**
- 3. fail to give further notices in order to bring up to date information given in this notice after my reelection or reappointment or fail to declare any disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.**

I also acknowledge that it may be a breach of the Code of Conduct to:

- 1. omit information that ought to be given in this notice;**
- 2. provide information that is materially false or misleading;**
- 3. fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change in circumstances**
